How to apply for Yilli Rreung Housing Aboriginal Corporation Membership

To be a member of the Yilli Rreung Housing Aboriginal Corporation you must meet the eligibility criteria according to the Corporation's Rule Book:

A person who meets all of the following criteria is eligible for membership:

- □ A person who is **at least 18 years** of age; A person who:
- is an Aboriginal and Torres Strait Islander person;
- A person who permanently resides within a distance of **250km of the Darwin GPO**;
- A person who is **not an employee** of the Corporation;
- A person who is **not an applicant for employment** with the Corporation; and
- A person who was not employed by the Corporation during the five (5) year period prior to making an application for membership of the Corporation.
- 1. If you are eligible for the membership and would like to be a member of YRHAC, please fill out the membership forms below (all these forms are included in this document):
 - (1) YRHAC Nomination Form for Membership
 - (2) Schedule 1–Application for membership form
 - (3) Code of Conduct of Directors, Members and Committee Members
- 2. Once filled out and signed, please return the form to the Chairperson/ Directors or Yilli Office (comms@yillihousing.com.au) along with your latest CV.
- 3. Your membership request will then be assessed by the Directors during a Directors' meeting. The Directors may refuse to accept a membership application. If they do so, they must write to the applicant about the decision and the reasons for it.
- 4. Once you are accepted as a member and registered in the corporation's register of members, you are officially a member of Yilli Housing.

You can stop being a member by resign in writing. Your membership will be cancelled in accordance with the rule book, if you can't be contacted for two (2) years, misbehaves, or you become ineligible to be a member.

- 1. All members should use the powers for a proper purpose, in the best interests of the corporation as a whole and should not take improper advantage of the position.
- 2. All members should not make improper use of information acquired and keep confidential information received as part of the corporation's property. It is improper to disclose it, unless that disclosure has been authorised by that corporation or is required by law.
- 3. All members must act in good faith in what they honestly believe to be the best interests of the corporation, and not for any collateral purpose. This means that, particularly in the event of a conflict of interest between the corporation's interests and their own, the member must always favour the corporation.
- 4. All members have an obligation to be independent and objective in judgement and actions and to take all reasonable steps to make sound decisions.
- 5. All members have an obligation, at all times, to comply with the law and should not engage in conduct likely to bring discredit upon the corporation.
- 6. All members must treat each other and staff with respect. Bullying and harassment will not be tolerated.
